1.) Webmaster services apply to all services for running and maintaining your website's/s' day-to-day activities. The Client shall be billed monthly for the full dues of any alterations, enhancements, and work done to the website, and agrees to this. If work done to the website is less than a full hour, than the Client shall be billed appropriately for the percentage of the hour worked. All webmaster services apply to the original Terms of Use found at the top of this page. Anevry agrees that all work to the website will be done within 12 hours of receiving the details for the update/maintenance. The Client, by signing, agrees to having signed and agreed to the Anevry Incorporated: General Terms and Conditions, and any other terms required by Anevry for their acceptance, as provided by Anevry and that if they have not, legal action may be taken along with a full Hold on their account.

2.) Invoicing shall be done by the Webmaster assigned to you, every _____, and you will also receive a direct representative e-mail address for use in contacting them in order to request all of the changes and services you need performed; this, and other information given to you by Anevry or the webmaster, shall be completely held confidential by you regardless of the current status of these webmaster services. No Anevry Webmaster may perform duties for more than five (5) websites, and if Client requires more Webmaster services then they must apply again, using this same form as many times as necessary to accomplish services sufficient enough to handle the websites they wish to have Webmasters for.
